3. CANDIDATES TO CHECK THEIR ELIGIBILITY BEFORE APPLYING

Exact Dates for submission of Online Application Form will be intimated in due course through a Press Release. Candidates who are desirous and eligible REPEAT: eligible only may apply through the ONLINE mode only after having satisfied themselves of their eligibility for this recruitment. (Please see *Para 15: Eligibility Conditions of Candidates to ensure their eligibility for the Post and Para 4: General Instructions*).

4. GENERAL INSTRUCTIONS

- a) Candidates are required to go through the Notification meticulously and decide themselves as to their eligibility with reference to the laid down criteria for this recruitment carefully, before applying and filling in all relevant columns in the Online Application Form
- b) Applications received online shall only be considered, and the Telangana State Level Police Recruitment Board (TSLPRB) will not be responsible for any kind of discrepancy
- c) TSLPRB will not be responsible for any inconsistencies or errors in the Application submitted online. Candidates are advised to strictly follow the instructions in their own interest and to verify the contents before submitting the Online Application Form
- d) Particulars furnished by the Candidates in the Online Application Form will be taken as final. Candidates should therefore be very careful in uploading / submitting the Online Application Form
- e) No relevant column of the Application Form should be left blank. Incomplete / Incorrect Online Application Form will be summarily rejected. Information, if any, furnished by the Candidate subsequently in any form will not be entertained by the TSLPRB under any circumstances. Candidates should be careful in filling out the Online Application Form before submission. If any lapse is detected at any stage of the recruitment process, the candidature will be rejected
- f) Candidates should not furnish any particulars that are false, tampered with, or fabricated. They shall not suppress or conceal any material information while filling out the Online Application Form. In case it is found at a later date that any false information has been provided, punitive action will be taken as per the law
- g) Candidates are expected to behave in an orderly and disciplined manner while appearing for the Tests / Examination / Certificates Verification. Any impersonation will be viewed adversely, and such Candidates shall be criminally prosecuted, besides being disqualified
- h) All the testimonials issued by the Competent Authorities shall compulsorily be produced as and when required. If the Candidate fails to produce the same, his / her candidature will be rejected / disqualified without any further correspondence

- i) The claim of the Candidates with regard to the Age, Date of Birth, Educational Qualifications, Community, etc., is accepted only provisionally based on the information furnished by them in their Online Application Form and Certificates produced, subject to verification and satisfaction of the TSLPRB, at an appropriate time. Mere acceptance of the Application, admission to any Exam, or inclusion of a Candidate in a Qualified Candidates List does not confer any right for selection. The candidature is therefore provisional at all stages and the TSLPRB reserves the right to reject his / her candidature at any stage of the selection without giving any notice.
- j) Care should be taken to ensure that the preference for Post Code Nos. 21, 22, 25 and 26 (for Men & Women), for Post Code Nos. 23 and 27 (for Men) and for Post Code No. 28 (for Women) is clearly given in the Application Form, while filling the Part – II Application
- k) Due to different Age relaxations being there, Age validation is not being done in the Online Application Form. It is the responsibility of the Candidates to satisfy themselves about their Age eligibility for the Post(s) applied for
- l) If Candidates who are Under-Aged or Over-Aged apply for this Recruitment Notification, their candidature will be rejected at any time, and TSLPRB is not responsible for the same. Fee once paid will not be refunded.

***Note:** As candidature for the recruitment is processed through Computer / Electronic devices, based on the particulars furnished in the Online Application Form, the Candidates are advised to fill in all the relevant particulars carefully.*

5. FEE

- a) OC and BC Candidates with local status of Telangana State applying for the Posts of SCT PC (Civil / AR / SAR CPL), SCT Constable in Special Protection Force Department, Fire Fighter in Telangana Fire, Disaster Response, Emergency & Civil Defence Department, Warder (Male) / Warder (Female) in Prisons & Correctional Services Department have to pay the fee as designated in the Online Application towards Registration of the Application, Processing of Application, Conduct of Tests and Examinations (PWT, PMT / PET, FWE & Certificates Verification), Maintenance of Portal etc. However, SC and ST Candidates who are Local to Telangana State have

to pay the concessional fee as designated in the Online Application. All other Candidates will have to pay the fee as designated in the Online Application.

b) For the Candidates who apply for more than one Notification issued by the TSLPRB within a period of 3 months from date of this Notification, the Physical Measurement Test / Physical Efficiency Test for all the Posts in the Notification(s) applied for by a Candidate, will be conducted only once and the same readings / scores will be valid for all the Posts for which he / she is applying for among the Notifications.

6. PAYMENT OF FEE

- I Step: Candidate has to register himself / herself on the TSLPRB Website – www.tgprb.in by making his / her Mobile Number as his / her User ID and then choose the Notifications and Posts that he / she would like to apply for. The fee payable will be determined based on the Posts he / she applies for. Candidates are advised to provide such Mobile Number as their Login ID which will be in currency throughout the process of recruitment and will be in their personal custody. It shall be their responsibility to ensure that this number is maintained continuously without any interruption throughout the process of recruitment, so that there will not be any loss of communication between the Board and the Candidates.
- II Step: This fee can be paid by using Credit Card, Debit Card, Net Banking or any other mode made available on the TSLPRB Website.
- III Step: After making the Payment, Candidate has to visit the website www.tgprb.in to submit the Online Application Form which is in 2 parts i.e., Part I and Part II. Part I Application has to be submitted initially along with a scanned copy of Passport Size Photo + specimen Signature combined as one file / image in jpg format. Even after making payment of fee and furnishing the details in the Application Form, if the Candidate fails to press submit button and the Application is not uploaded, such applications shall be rejected without giving any notice. Fee once paid will not be refunded in any case.
- IV Step: Candidates who are declared qualified in Preliminary Written Test have to visit the website www.tgprb.in again for uploading the Part-II Application along with the scanned copies of Certificates / Documents. For this, dates will be announced later.

7. CANDIDATES SHOULD KEEP READY WITH THE FOLLOWING DOCUMENTS TO APPLY

Candidates are requested to keep ready with the following documents before the schedule for submitting the Online Application Form

- i. Latest SC Community Certificate with sub-classification of SC Group I, SC Group II and SC Group III issued by the Competent Authority of Government of Telangana (For SC Candidates only)

- ii. Latest Economically Weaker Section (EWS) Category Certificate issued by the Competent Authorities of Government of Telangana issued on or after 1st April 2026, wherever applicable
- iii. Latest Non-Creamy Layer Certificate issued by the Competent Authority of the Government of Telangana, issued on or after 1st April 2026 (For BC Candidates only)
- iv. Local Candidature Certificates, i.e., Bonafide from 1st to 7th Class (or) Residence Certificate, wherever applicable
- v. Special Category Certificates like Home Guard and Children of Police Personnel, etc.

8. INSTRUCTIONS FOR FILLING PART-I ONLINE APPLICATION

- a) Candidates are requested to check their eligibility carefully and fill in all the relevant columns in the Part I Application Form. Candidates should not register more than one Application Form for the present Recruitment Process, which intends to collect information for all the Posts notified through 4 (four) different Notifications with Notification Nos. 189 / Rect. / Rect.-2 / 2026, 225 / Rect. / Rect.-1 / 2026, 234 & 279 / Rect. / Rect.-3 / 2026, dated 29-07-2026
- b) The following steps are to be followed by the Candidates who intend to submit the online Application through the payment gateway –
 - i. Registration using Mobile Phone as User ID
 - ii. Select the Post(s) for which he / she wants to apply as per the eligibility
 - iii. Note the Fee that has to be paid depending on the Posts chosen
 - iv. Payment of Fee using any mode made available
 - v. Continue on the TSLPRB Website with the User ID and fill Part I of the Application
 - vi. Scan and upload a copy of Passport Photograph and Specimen Signature as one file
 - vii. Submit the Application Form

- c) Candidates should keep ready a soft copy of his / her Passport Size Photo + specimen Signature combined as one file image in jpg format, as shown below, to be scanned and uploaded with the Online Application

- d) **Application will be rejected if the Candidate uploads the Photo without a signature.** The size of the above image / file should not exceed **100kb (Minimum size is 30kb)**. Please note that if the file is not in JPG format, the system will reject it, and the candidate may not be able to complete the process of filling up the remaining details of the Online Application Form.
- e) After payment of the fee, Candidates can use the "Apply Online" in the main menu option on the website (www.tgprb.in) to fill his / her Part I Application Form.
- f) Candidates are advised to carefully read all the instructions and understand before clicking on "I AGREE".
- g) **Candidates should endorse the declaration at the end of the Online Application, signifying the fact that they have read and understood all the Rules and Regulations and that they agree to scrupulously abide by them and confirm with an OTP (One Time Password) sent to the Candidate's Registered Mobile.**
- h) Once the Candidate submits the Application Form, no corrections can be made. Hence, candidates are requested to carefully verify the details before submission.
- i) After submission of the Online Application Form, the Candidate must download a copy of his / her submitted form in PDF for future use.

9. INSTRUCTIONS FOR FILLING PART-II ONLINE APPLICATION

- a) Candidates who are declared qualified in the Preliminary Written Test have to visit the website www.tgprb.in again to submit the Part-II Application.
- b) Post Codes are from 21 to 23 and 25 to 28. Post Preferences / Unit Options once exercised are final and cannot be changed thereafter. Candidature will

be considered as per the preferences indicated in the Application Form, based on eligibility. Candidature will not be considered for those Posts / Units which are left blank / unfilled by the Candidates

- c) Giving false information, suppression, or concealment of facts will result in the disqualification of the Candidates and render them liable for Prosecution
- d) Once the Candidate submits the Application, no corrections can be made. Hence, candidates are requested to carefully verify the details before submission
- e) Candidates are advised to carefully read all the instructions and understand before clicking on "I AGREE"
- f) After successful submission of the Online Application, the Candidate will receive an Acknowledgment through his / her email ID. (Check SPAM folder of your email account if you have not received it in INBOX). The Candidate must download a copy of his / her submitted form in PDF for future use.
- g) Candidates are advised to fill their Online Application Form themselves instead of handing it over to others to avoid any wrong entries. If their Online Application Form is being filled by some other person, the Candidate should personally be available and ensure that the entries are made correctly and the Online Application is uploaded successfully.
- h) Candidature is provisional at all stages. Mere issuance of Hall Ticket to the Candidates allowing them to attend the Examination(s) / Test(s) will not imply that Candidature has been finally cleared by the TSLPRB. 11. RULES GOVERNING THE POST(S)

- b) Recruitment to the Post of the Telangana Special Protection Force Department (Post Code No. 25) is being made under the Telangana Special Protection Force Stipendiary Cadet Trainee Rules, 2026, issued in GO Ms No. 46, Home (Services III) Department, dated 18-05-2026.
- c) Recruitment to the Post of the Telangana Fire, Disaster Response, Emergency & Civil Defence Department (Post Code No. 26) is being made as per the provisions of Special Rules for the Telangana Fire, Disaster Response, Emergency & Civil Defence Subordinate Service, 2025 issued in GO Ms No. 86 Home (Services IV) Department dated 11-07-2025 r/w GO Ms No. 551 Home (Services IV) Department dated 17-07-2026.
- d) Recruitment to the Posts of the Telangana Prisons and Correctional Services Department (Post Code Nos. 27 & 28) is being made as per the provisions of Telangana State Jail Subordinate Service Rules issued in GO

Ms No. 514 Home (Prisons A) Department dated 23-11-1993 r/w GO Ms No. 303 Home (Prisons A) Department dated 20-12-2007 and further amendments issued thereon from time to time by the Government r/w GO Ms No. 17, Home (Legal) Department, dated 22-04-2022.

12. SPECIAL REPRESENTATION (RESERVATION)

A) Reservation:

The rule of Special Representation (Reservation), i.e., BC-A, BC-B, BC-C, BC-D, BC-E, SC, ST, Ex-Servicemen, Meritorious Sports Person, and Economically Weaker Section category provided in Rule 22 of Telangana State & Subordinate Service Rules, 1996, shall be applicable to all the Posts. Further, Rule 22-A of the Telangana State and Subordinate Service Rules 1996 shall be applicable only to the Post Code Nos. 21, 25, and 26.

B) Community:

- i. SC and ST Candidates who are local Candidates to Telangana State as per the definition given in the Presidential Order, 2018, are required to produce the latest Community Certificate issued by the Competent Authority of the Government of Telangana State for claiming Age relaxation / reservation. Candidates who belong to the SC Category should submit a Community Certificate as per Act No. 15 of 2025, dated 14-04-2025, issued by the Government of Telangana with regard to reservations to SCs by way of sub-classification in the State, i.e., SC Group - I, SC Group - II, and SC Group – III.
- ii. BC Candidates who are local Candidates to Telangana State as per the definition given in the Presidential Order 2018, are required to produce Community Certificate (BC-A, BC-B, BC-C, BC-D & BC-E) from the Competent Authority of the Telangana State Government.
- iii. Candidates belonging to Backward Classes shall submit the Community Certificate to claim Age relaxation and the latest Certificate of Non-Creamy

Layer issued by the Competent Authorities of Telangana State on or after 01-04-2026 to claim Reservation. In case of failure to produce the Non-Creamy Layer Certificate on the day of Certificates Verification, such Candidates will be considered under “Open Competition”, if otherwise eligible, and the status cannot be changed later.

- iv. Relaxation in upper age limit and / or reservation to BC-E Group will be subject to the adjudication of the litigation pending before the Honourable Courts including final orders in Civil Appeal No(s). 2628-2637 of 2010 in SLP No. 7388-97 of 2010 dated 25-03-2010 and orders of the Government.
- v. BC, SC, and ST Candidates who are not local to Telangana State, as per the Presidential order 2018, are not entitled to any kind of reservation.

C) Economically Weaker Section (EWS):

Candidates who are local Candidates to Telangana State as per the definition given in the Presidential Order 2018 and belonging to Economically Weaker Section category (as per GO Ms No. 65, GA (Ser. D) Department, dated 19.03.2021 r/w GO Ms No. 244, GA (Ser. D) Department, dated 24-08-2021) shall submit the Income and Asset Certificate issued by any of the following Authorities of Government of Telangana State to claim Age relaxation and Reservation under this Category.

- i) District Magistrate / Additional District Magistrate / Collector / Sub-divisional Magistrate / Mandal Revenue Officer
- ii) Revenue Officer not below the rank of Tahsildar and
- iii) Sub-Divisional Officer of the area where the Candidate and / or his family normally resides

D) Meritorious Sports Persons:

Persons who satisfy the definition given in sub-rule (20) of Rule 2 of Telangana State and Subordinate Service Rules, 1996, and who possess the necessary certificate issued by the Competent Authority clearly certifying that the qualifying participation was prior to the date of this Notification, will come under this reservation, and it will be applicable to the following categories only:

Category 1- A sportsperson who won medals or represented India in an International Competition / Multinational Competition in any one of the recognized Games/Sports which are mentioned in Annexure I of GO Ms No. 74, YATC (Sports) Department, dated 9-8-2012, and as subsequently amended from time to time

Category 2 - A sportsperson who won medals or represented a State in India in a National Competition in any one of the recognized Games/Sports which are mentioned in Annexure I of GO Ms No. 74, YATC (Sports) Department, dated 9-8-2012, and as subsequently amended from time to time

Category 3 - A sportsperson who won medals or represented a University from the State of Telangana in the Inter-University Competition at the National level / Zonal level / Regional level in any one of the recognized Games/Sports which are mentioned in Annexure I of GO Ms No. 74, YATC (Sports) Department, dated 9-8-2012 and as subsequently amended from time to time

Note:-i) Candidates who come under category (1) above shall be considered initially to fill the vacancies under MSP reservation. If sufficient Candidates of Category (1) are not available, then the Candidates from Category (2) and thereafter from Category (3) shall be considered for the relevant Posts.

ii) Where there is a larger number of Candidates possessing the certificates of the same category available, then marks secured by them during the final selection shall be taken to decide the inter-se-merit

iii) In the event of non- availability of eligible sports persons, the vacancies reserved for them shall be allotted to Open Competition in the same recruitment

E) WOMEN'S RESERVATION

33⅓% of the vacancies in each category including EWS are reserved for Women for the Post Code No. 21, 25 and 26. Similarly, 10% of the vacancies in each category, including EWS, are reserved for Women for the Post Code No. 22 under Direct Recruitment, in relaxation of relevant rules relating to Telangana State and Subordinate Service Rules, 1996. The reservation for Women will be a horizontal reservation following the principle of sufficiency i.e., the reservation of Women Candidates shall be adjusted proportionately in the respective category to which the Woman Candidate belongs. In the event of non-availability of eligible and qualified Women Candidates, the vacancies reserved for them shall not be carried forward for the succeeding recruitment and shall be filled up by Men Candidates of respective Communal Category.

13. INSTRUCTIONS TO BE READ CAREFULLY

The requisite Educational qualification, Age, Physical standards, Procedure to be followed for selection etc., is given below. Candidates must read the instructions given in this Notification carefully in their own interest.

14. SPECIAL CATEGORIES RESERVATIONS FOR TELANGANA LOCAL CANDIDATES ONLY

All Special Category reservations are applicable to the Local Candidates of Telangana State only (as per the definition given in the Presidential Order 2018). Vacancies reserved for Special Categories i.e., National Cadet Corps (NCC); Home Guard (HG); Children of Police Personnel (CPP); Children of Deceased & Incapacitated Police Personnel (CDI); Children of Prisons Department Personnel (CJP); Children of Special Protection Force Personnel (CSPF); and Children of members of Fire Services (CFSP) shall be adjusted in a horizontal manner i.e., the reservation of Special Category Candidates shall be adjusted proportionately in the respective Communal Category to which the Candidate belongs. The percentage of vacancies reserved for the above Special Categories shall be calculated for each category based on the vacancies notified.

15. ELIGIBILITY CONDITIONS (CANDIDATES TO ENSURE THEIR ELIGIBILITY FOR THE EXAMINATION)

Candidates applying for the examination should ensure themselves that they fulfil all the eligibility conditions for admission to the examination. Their admission at all the stages of the Examination(s) / Test(s) will be purely provisional and shall be subject to satisfying the prescribed eligibility conditions.

The mere issue of the Hall Ticket to the Candidate will not imply that his / her candidature has been finally cleared by the Board.

TSLPRB will take up verification of eligibility conditions with reference to Original documents only after the Candidate has finally qualified or at an appropriate time.

A. Eligibility by Gender: For Post Code Nos. 21, 22, 25, and 26, both Men and Women are eligible; for Post Code Nos. 23 and 27 only, Men are eligible, and for Post Code No.28, only Women are eligible.

B. Age Limit (General)

i) For the Post Code Nos. 21 to 23, 25 & 26:

- a) Must have attained the age of 18 years and must not have attained the age of 22 years as on 1st July, 2026. However, the Government of Telangana vide GO Ms No. 87, General Administration (Services-A) Department dated 18-05-2026 has raised the upper age limit prescribed for direct recruitment by 5 (five) years for uniformed services, including Police, Fire Services, Prisons, and Special Protection Force Departments. This relaxation is in addition to the upper age limit as mentioned above.
- b) For Home Guards, a Person who, as on the date of Notification, has been on duty as Home Guard for a minimum duration of 360 days within a period of 2 (two) years and who is still continuing his / her service as

Home Guard, must have attained the age of 18 years and must not have attained the age of 40 years as on 1st July, 2026. However, the Government of Telangana vide GO Ms No. 87, General Administration (Services-A) Department dated 18-05-2026 has raised the upper age limit prescribed for direct recruitment by 5 (five) years for uniformed services, including Police, Fire Services, Prisons, and Special Protection Force Departments. This relaxation is in addition to the upper age limit as mentioned above.

ii) **For the Post Code Nos. 27 & 28:** Must have attained the age of 18 years and must not have attained the age of 22 years as on 1st July, 2026. However, the Government of Telangana vide GO Ms No. 87, General Administration (Services-A) Department dated 18-05-2026 has raised the upper age limit prescribed for direct recruitment by 5 (five) years for uniformed services, including Police, Fire Services, Prisons, and Special Protection Force Departments. This relaxation is in addition to the upper age limit as mentioned above.

iii) **For the Post Code Nos. 21, 22, 25, 26 & 28 (For Women Candidates):** In the case of a Widow, a Divorced Woman or a Woman judicially separated from her husband and who is not remarried,

a) SC & ST Candidates must have attained the age of 18 years and must not have attained the age of 40 years as on 1st July, 2026. However, the Government of Telangana vide GO Ms No. 87, General Administration (Services-A) Department dated 18-05-2026 has raised the upper age limit prescribed for direct recruitment by 5 (five) years for uniformed services, including Police, Fire Services, Prisons, and Special Protection Force Departments. This relaxation is in addition to the upper age limit as mentioned above.

- b) In all other cases (other than SC & ST), the Candidate must have attained the age of 18 years and must not have attained the age of 35 years as on 1st July, 2026. However, the Government of Telangana vide GO Ms No. 87, General Administration (Services-A) Department dated 18-05-2026 has raised the upper age limit prescribed for direct recruitment by 5 (five) years for uniformed services, including Police, Fire Services, Prisons, and Special Protection Force Departments. This relaxation is in addition to the upper age limit as mentioned above.

Note: A woman candidate claiming Age relaxation by virtue of being either a widow, a divorcee, or a Woman judicially separated should produce the following documentary evidence.

- a) In case of a widow, the death certificate of her husband together with the Affidavit duly notarised stating that she has not remarried since.*
- b) In case of Divorced Women and Women judicially separated from their husband, a certified copy of the Judgment / Decree of the appropriate court to prove the fact of divorce or the judicial separation, as the case may be, along with an Affidavit duly notarised that she has not remarried since.*

- iv) **Relaxations in Upper Age Limit:** The Upper age limit prescribed above is however relaxable in the following cases:

As provided above, the age limits prescribed can in no case be relaxed.

Note:

1. Persons serving in the Armed Forces of the Indian Union, who on Retirement from Service, would come under the category of Ex-Servicemen, may be permitted to apply for re-employment one year before the completion of the specified terms of engagement and avail themselves of all concessions available to Ex-Servicemen

2. Name and date of birth accepted by the TSLPRB is that entered in the Secondary School Certificate, Matriculation, or an equivalent examination certificate. No other document relating to age, like horoscopes, affidavits, birth extracts from Municipal Corporation, Service Records, and the like, will be accepted

C. Educational Qualification: Must have passed Intermediate or its equivalent examination recognized by the State Government as on the date of Notification i.e., 29th July 2026.

Provided that, Intermediate Pass Certificate cum Memorandum of Marks or any equivalent pass Certificate which proves the qualification shall be made available by the Candidate at the time of certificate verification to prove his / her qualification on or before 29th July 2026. If any Candidate fails to produce the required pass certificate as above on the designated day, then it shall be

deemed that he / she does not possess required qualification and such candidature shall not be taken forward. Any certificates produced after the last date of Certificate Verification shall not be taken into consideration.

Note: *Candidates who possess higher qualification than the prescribed one will also be considered on par with the Candidates who possess the prescribed qualification.*

D. Technical qualification for Post Code 26: Candidates must have possessed valid Light Motor Vehicle (LMV) driving license as on the date of Notification.

Note: *Candidate should furnish the valid Driving License Information (Grant of Issue of Driving License) issued by the Licensing Authority of the RTA concerned at the time of Certificates Verification.*

E. Medical Standards:

- i) Eye Sight: Visual Standards required for the above selection shall be as follows –

- ii) Each eye must have a full field of vision
- iii) Colour blindness, squint, or any morbid condition of the eye or lids of either eye shall be deemed to be a disqualification
- iv) Candidate should possess sound health and be free from any bodily defect or infirmity which will render him / her unfit for the Posts notified
- v) Candidates who have the following ailments or defects will not be considered for recruitment to any post specified in this rule

- Physically handicapped
 - Knocking-knees, pigeon chest, flat foot, Varicose veins, Hammer toes, fractured limbs, decayed teeth, stammering, hard of hearing and abnormal psychological behaviour
- vi) Candidates provisionally selected shall be referred to the District Headquarter Hospital for Medical Examination / Fitness. For any expert opinion, Candidates shall be referred to Osmania / Gandhi Hospitals, Hyderabad, on the basis of the recommendations made by the District Headquarters Hospitals. Candidates who are declared unfit in eye related issues shall be referred to the Sarojini Devi Eye Hospital, Hyderabad based on the recommendation made by the District Headquarters Hospital. The opinion given by the Sarojini Devi Hospital shall be final. The Candidates can be referred / examined only once on such recommendations. There shall not be any further re-examination once the Candidate is already examined as per the referral of the District Headquarters Hospital for expert opinion. Where there is no referral for expert opinion from the District Headquarters Hospital, such Candidates shall not be referred any further.

Note:- In order to avert getting disappointed at a later stage, Candidates are advised to have themselves examined by a Civil Surgeon before applying for the examination to ensure that they meet the prescribed Physical and Medical Standards.

16. SELECTION PROCEDURE / SCHEME

The Selection Procedure/Scheme of the Examination will be as follows --

A) Preliminary Written Test (PWT): All the eligible registered Candidates shall be required to appear for the Preliminary Written Test in one paper (three hours duration) for 200 marks (200 Questions). Hall Ticket will be issued Online for this purpose. Syllabus for the PWT is given at Annexure - II.

Note:

1) The minimum marks to be secured by the Candidates in order to qualify in the Preliminary Written Test paper is 30% for OCs including EWS, 25% for BCs and 20% for SCs / STs / Ex-Servicemen / Home guards.

2) Questions in the Paper shall be objective in nature. Candidates have to answer the questions on an OMR answer sheet using Blue / Black Ball Point pen only.

3) For each question, the Candidate shall be awarded full marks, assigned to that question, if he / she darkened only one bubble that corresponds to the correct answer. In case the Candidate has not darkened any bubble, the Candidate shall be awarded zero mark for that question. In all other cases, 20% of full marks shall be awarded as negative mark for that question.

4) Questions in the Written Test shall be set in English-Telugu & English Urdu languages and in case of terminology of Science technology / Management transliteration will be employed at the experts discretion. In case of any ambiguity or spelling mistake in Translation / Transliteration in any Question in Telugu or Urdu language, English version shall be considered as final and the correct version.

5) Wherever any question/s are deleted in the final Answer key in Preliminary Written Test, each Candidate will be compensated with reference to deleted questions in proportion to percentage of the marks obtained by him / her in the other questions (which remain undeleted).

Intimation Letter: Candidates who qualify in the Preliminary Written Test will be informed the dates for downloading the Intimation Letter through the website www.tgprb.in for appearing in the PMT / PET with details of Venue, Date and Time. Candidates should bring the Intimation Letter while attending the PMT / PET.

B) Sequence of Physical Efficiency Test and Physical Measurements:-

Candidates who qualify in the above Preliminary Written Test, shall be required to undergo the following tests and qualify as specified below:

i) 1600 meters / 800 meters Run event:- Men Candidates must qualify in the 1600 meters Run within a maximum time of 7 Minutes 15 Seconds. For Ex-Servicemen, the maximum time is 9 Minutes 30 Seconds. Women Candidates must qualify in 800 meters Run within a maximum time of 5 Minutes 20 Seconds. For Post Code Nos. 21, 26, 27 and 28, the Run event is qualifying in nature. For Post Code Nos. 22, 23, and 25 – Candidates shall be awarded marks for their performance in the Run event as shown in Annexure – I.

While conducting the 1600 meters and 800 meters Run events where RFID based readings is taken the competitors perform totally independent of each other. Consequently, starting-time, finishing-time and duration are automatically recorded individually for each competitor. Nevertheless, wherever required, only curved-start (not staggered-start) method wherein the competitors can change lanes immediately after the start will be adopted. All digitally recorded readings shall be rounded mathematically to 2 decimal places to determine qualification / disqualification and also gradation

For Post Code No. 22 i.e., SCT PC (AR) and Post Code No. 25 i.e., SCT Constable in SPF, the marks secured by men and Women in the Run event shall be normalized using the following formula or any other procedure / formula to be adopted by the TSLPRB as approved by the Government, to ensure fairness. The normalized marks in the 1600 meters / 800 meters Run event shall be taken while drawing the final merit list.

Subscript_{ST} = of the Top 0.1% or Top 10 (whichever is higher) Candidates among all the Qualified Candidates pertaining to the Gender Group of the Candidate

The Normalized marks will be rounded up to the third decimal place and their value will be considered as it is.

ii. Physical Measurements: Candidates, who qualify in the above Run event, should meet the following requirements:

- a) For the Post Code Nos. 21 to 23 and 25 to 27 (Men):
Height: Must not be less than 167.6 cms
- b) For the Post Code Nos. 21,22, 25, 26 and 28 (Women):
Height: Must not be less than 152.5 cms

Provided that, Candidates belonging to Scheduled Tribes & Aboriginal tribes in the Agency Areas of Adilabad, Komarambheem-Asifabad, Mancherial, Nagarkurnool, Khammam, Bhadrachari-Kothagudem, Mulugu, Mahabubabad and Warangal districts should meet the following requirements:

- c) For the Post Code Nos. 21 to 23 and 25 to 27 (Men):
Height: Must not be less than 160 cms
- d) For the Post Code Nos. 21, 22, 25, 26 and 28 (Women):
Height: Must not be less than 150 cms

iii. Long jump / Shot-put events: Candidates declared qualified in the Physical Measurements as above shall be required to undergo the remaining PET events and must qualify as detailed below:

Note: *Physical Measurement Test / Physical Efficiency Test for all the Posts in the Notification(s) issued by TSLPRB (within a period of 3 months) applied for by a Candidate, will be conducted only once and the same readings / scores will be valid for all the Posts for which he / she is applying for among the Notifications.*

Intimation Letter: Candidates who qualify in the Physical Measurement Test / Physical Efficiency Test will be issued Hall Tickets for appearing in the Final Written Examination with details of Venue, Date and Time. Candidates should bring the Hall Ticket when they come to attend the Final Written Examination.

C) Final Written Examination (FWE): Candidates who qualify in the above Physical Efficiency Test shall be required to appear for the Final Written Examination for 1(one) paper of 3 (three) hours duration, as described below. Syllabus for this exam is given in Annexure - III.

1) *The minimum marks to be secured by the candidates in order to qualify in the final written examination in the paper is 40% for OCs including EWS, 35% for BCs and 30% for SCs / STs / Ex-Servicemen. The same minimum qualifying marks shall apply to the Candidates who belong to special categories referred at para 21 in respect of their open / social categories.*

2) *Questions in written examination will be objective in nature. Candidates have to answer the questions on an OMR answer sheet using Blue / Black Ball Point pen only.*

3) *Questions in the Written Examination shall be set in English-Telugu & English Urdu languages and in case of terminology of Science technology / Management transliteration will be employed at the experts discretion. In case of any ambiguity or*

spelling mistake in Translation / Transliteration in any Question in Telugu or Urdu language, English version shall be considered as final and the correct version.

4) While evaluating Objective type Papers, the marks for the deleted questions, if any, will be awarded to each Candidate proportionately and the marks would be considered up to 3 (three) decimal places, to determine the merit of the Candidate. Thus, with reference to deleted questions, each Candidate will be compensated in proportion to his / her percentage of marks obtained in the rest of the questions (which remain undeleted).

5) Appearance in all the Test(s) and Written Examination(s) is compulsory. Absence in any of the above Test(s) / Examination(s) shall automatically render a Candidate disqualified

6) Mere securing of minimum qualifying marks does not vest any right in a Candidate to be considered for selection

D) No Postponement / Reconsideration of Tests including PMT / PET during recruitment process:- Candidates should be fit in all aspects at all stages of recruitments including PMT / PET. No Postponement / reconsideration of stages under any circumstances shall be allowed. A Candidate has to undergo the tests including PMT / PET on the designated day in the sequential order as prescribed above.

E) Final Selection:

i) For Post Code No. 21: The final selection of the Candidates will be made strictly on relative merit, as obtained by them based on their score in the Final Written Examination. 95% of the vacancies of SCT PC (Civil) in the Police Districts / Commissionerates as organised under “The Telangana Public Employment (Organization of Local Cadres and Regulation of Direct Recruitment) Order, 2018” r/w GO Ms No 170, GA (SPF.II) Department, dated 04-08-2021 shall be filled up from the local Candidates of the respective Police Districts / Commissionerates.

ii) For Post Code No. 22: The final selection of the Candidates shall be made strictly on their relative merit, as obtained by them based on their score in the Final Written Examination and Physical Efficiency Test (1600 mtrs / 800 mtrs run). The marks secured by Men and Women in PET shall be normalized by using the formula prescribed by the TSLPRB to ensure fairness. The said normalized marks shall be the basis for drawing the Final common Merit List. 95% of the vacancies of SCT PC (AR) in the Police Districts / Commissionerates as organised under “The Telangana Public Employment (Organization of Local Cadres and Regulation of Direct Recruitment) Order, 2018” r/w GO Ms No. 173, GA (SPF.II) Department, dated 04-08-2021 shall be filled up from the local Candidates of the respective Police Districts / Commissionerates.

iii) For Post Code No. 23: The final selection of the Candidates shall be made strictly on their relative merit, as obtained by them based on their aggregate score of the Final Written Examination and Physical Efficiency Test (1600 meters Run event). The provisions of “The Telangana Public Employment (Organization of Local Cadres and Regulation of Direct Recruitment) Order, 2018” are not applicable to this selection of SCT PC (SARCPL). To avail of any vertical or horizontal reservation, the Candidate must be a Local of Telangana State as defined in the Presidential Order and having Community Certificate issued by the Competent Authority of Telangana State.

vi) For Post Code Nos. 27 and 28: The final selection of the Candidates will be made strictly on relative merit, as obtained by them based on their score in the Final Written Examination. 95% of the vacancies of Warders (Male) / Warders (Female) in each District of Contiguous District cadres as organised under “The Telangana Public Employment (Organization of Local Cadres and Regulation of Direct Recruitment) Order, 2018” r/w GO Ms No 54, GA (SPF.II) Department, dated 20-04-2022 shall be filled up from the local Candidates of the respective Districts of Contiguous District cadres as per GO Ms No. 46, GA (SPF. II) Department, dated 04-04-2022.

F) Merit among Candidates who secure same Marks: When 2 (two) or more Candidates in a particular category obtain equal marks, preference will be given to the Candidate who was born earlier.

17. CERTIFICATES VERIFICATION

19. LOCAL RESERVATION

- iii) **For Post Code No. 25:** 25% for Home Guards (HG), 5% for Children of Special Protection Force Personnel (CSPF) and 2% for NCC
- iv) **For Post Code No. 26:** 5% for Home Guards (HG) and 5% Children of members of Fire Services
- v) **For Post Code 27:** 5% for Children of Prisons Department Personnel (CJP)

21. SPECIAL CATEGORIES

Candidates who claim Reservation / Quota under following Special Categories should satisfy the given conditions:

- i) **National Cadet Corps (NCC)** - Candidates who possess NCC-A, NCC-B and NCC-C certificates issued by the Competent Authorities are equally eligible and shall be considered as per merit secured by them in the final selection. When two or more Candidates secure same marks, preference shall be given to the Candidate who possess higher certificate.
- ii) **Home Guard (HG)** – Persons who, as on the date of Notification, shall be on duty as Home Guards for a minimum period of 360 days within a period of 2 (two) years and who are still continuing their service as Home Guards come under this Special Category.
- iii) **Children of Police Personnel (CPP)** – Children of Police Constables and up to the rank of Inspectors of Police working in Telangana State Police department, as on date of notification, who are either in service in those ranks or retired or died are eligible under this quota. The benefit is to be limited only to the first two children in a family.

iv) Children of Deceased and Incapacitated Personnel (CDI) – (1) Children of Police Personnel of Telangana State Police Department who (a) died due to violent action of Extremists/Criminals/ Anti-social elements or (b) were Incapacitated and were Retired on Medical Invalidation due to violent action of the Extremists / Criminals / Anti-social elements and (2) Children of Police personnel of Telangana State Police Department who (a) died due to violence while on duty or (b) were Incapacitated and were Retired on Medical Invalidation due to violence while on duty are eligible under CDI quota.

v) Children of TGSPF Members (CSPF) – Children of Constables and up to the rank of Inspectors working in Telangana Special Protection Force department as on date of recruitment notification, who are either in service in those ranks or retired or died are eligible under this quota. The benefit is to be limited only to the first two children in a family.

vi) Children of Prisons Department Personnel (CJP)– Children of Prison Personnel up to the rank of Jailor Working / Retired / Deceased, while in service, in Telangana State Prisons and Correctional Services Department, shall come under this Special Category.

vii) Children of Members of Fire Services (CFSP) – Children of members of Fire Services up to the rank of Assistant District Fire Officer who have retired / deceased / incapacitated, as on date of this notification, are eligible under this quota.

Note:

(i) The vacancies which remain unfilled in any one of the above Special Categories, the same shall be filled up by the general Candidates of respective open category and social categories in the selection.

(ii) The quota reserved under Special Categories, for the Notifications issued by TSLPRB, are applicable only to the local Candidates of Telangana State as per the definition of Local Candidate given in Presidential Order, 2018 and must possess Community Certificate issued by the Competent authorities of Telangana State.

(iii) Children of Police Personnel who were compulsorily retired or removed or dismissed from service as a measure of Punishment shall not be considered under the quota of 'Children of Police Personnel' (CPP).

(iv) Children of members of Special Protection Force who were compulsory retired or removed or dismissed from service as a measure of punishment shall not be considered under the quota of Children of Members of Fire Services (CFSP).

22. CERTIFICATES / ANNEXURES

a) Candidates who claim any reservation / quota under Home Guard, CPP, CDI, CSPF, CJP and CFSP should satisfy the above conditions and submit the relevant certificate(s) as per the Annexure(s) appended to the Notification. **Certificates pertaining to the above Special Categories shall be valid and acceptable if they are obtained on or after the date of this Notification from the Competent Authority. Certificates obtained prior to the date of this Notification are not valid and will not be entertained.**

b) Candidates who claim Reservation / Quota under NCC (A, B or C certificate) should submit the necessary certificate issued on or before the date of this Notification by the Competent Authority.

23. NECESSARY CERTIFICATE FOR EX-SERVICEMEN

Candidates who claim reservation as Ex-Servicemen should satisfy the conditions mentioned in Sub-Clause (16) of Rule 2 of Telangana State and Subordinate Service Rules, 1996 and shall have the necessary certificate from the Competent Authority (PPO – Pension Payment Order, Discharge Book and NOC whichever is applicable).

24. SELECTION TO BE PROVISIONAL

Selection of Candidates shall be provisional and be subject to verification of the original certificates, antecedents, medical fitness and also outcome of disciplinary proceedings, if any, pending against the serving employees.

25. INCLUSION IN MERIT LIST DOES NOT CONFER ANY RIGHTS

Mere admission to any test or inclusion of a Candidate's name in a Merit List shall not confer on him / her any right for Selection / Appointment to such service, class or category. The provisional selection of the Candidates to the Posts mentioned in this Notification, are subject to the several other requirements described below

Provided that the State Government may, if satisfied that such marriage is permissible under the personal law applicable to such person, exempt any person from the operation of this rule
 - (iv) A person who has been Dismissed from the Services of a State or Central Government or from the service of any Central or State Government Undertaking or Local body or any other authority
 - (v) A person who has been convicted for any offence except in cases where imposition of fines under MV Act and imposition of fines in summary trial cases.
 - (vi) A person who is involved in criminal case(s) that are grave / serious nature (or) involving moral turpitude.

26. SUPPRESSION / WITHHOLDING OF FACTS – NOT ADVISABLE

Suppression of Material facts or withholding any factual information in the Application Form or Attestation Form (which would be supplied to the Candidates who are declared provisionally selected) will disqualify the Candidate from being considered for appointment. In the event of any information being found false or incorrect or ineligibility being detected at any time even after Appointment, he / she will be discharged from service forthwith by the Appointing Authority without any notice.

27. FALLOUT VACANCIES

There shall be no waiting list for any of the recruitment processes conducted by TSLPRB and the list of Candidates provisionally selected as against the notified Posts shall be final and there shall not be any sliding under any circumstances. The fallout vacancies, if any, due to cancellation of provisional selection for any reasons including adverse Antecedents, Lack of Medical fitness, relinquishment by the Candidates and non-joining of the Induction Training as per designated procedure etc., of the provisionally selected Candidates shall deemed lapse for the recruitment notified.

28. APPOINTMENT ON COMPLETION OF INDUCTION TRAINING

Candidates who are provisionally selected to the SCT Posts of Police Department will be appointed to the regular Posts by the concerned Appointing Authorities, only on successful completion of Induction Training.

29. RESIGNATION AND RELIEF FROM EARLIER EMPLOYER NECESSARY PREREQUISITE TO JOIN TRAINING

Candidates who are provisionally selected for any one of the Posts specified in this Notification and is an employee of Telangana State Government / any other State Government / Central Government / any Public Sector Undertaking / Government Enterprise can join training only after relief from the earlier employer / after resignation to the earlier service. Such relief / resignation should be obtained well before the commencement of training and submitted to the concerned Appointing Authorities for necessary action.

30. TIME LIMIT FOR SUBMISSION OF FORMS

Time limit for submission of Attestation Forms (or) other relevant documents (or) attending Medical Examination (or) joining the Induction Training: i) Candidates who are provisionally selected for any one of the Posts specified in this Notification will be asked to submit an Attestation Form, produce other relevant documents and attend Medical Examination on a specified date. Candidates who become eligible to be sent for training will be asked to join the training on a specified date. If any Candidate fails to respond and submit the necessary form(s) or document or attend the Medical Examination or join the training on a specified date, his / her provisional selection will be cancelled without any further notice to the Candidate. The Candidates who are found fit in all aspects and become eligible, the list of such Candidates will be sent to the concerned Heads of Departments for further action.

ii) If any Candidate finally selected as above fails to join the training on the specified date or seek postponement of training for any reason, further action either to cancel the selection or postponement of training shall be taken by the concerned Heads of the Departments. iii) If any Candidate subsequent to his / her selection is unable to join the original Induction Training Batch meant for the respective Post of the selection for reasons attributed to the Candidate; and such situation continues till the conclusion of the usual date of declaration of probation of the said batch, then such Candidate/s shall undergo the Physical Efficiency Test prescribed for recruitment purposes as on the date of the conduct of such test, only those Candidates who cleared the Physical Efficiency Test shall be allowed to be considered for selection / consequent Induction Training.

31. STIPEND AND ALLOWANCE

32. PENSION RULES

Employees who are appointed on or after 01-09-2004 are covered by the Contributory Pension Scheme. Existing Pension Scheme as per Revised Pension Rules, 1980 as applicable to the State of Telangana, will not be applicable to them.

Candidates are advised to visit the website of TSLPRB regularly to keep themselves updated until completion of the recruitment process. Candidates are further advised not to rely on rumours and false propaganda resorted to by persons with vested interests through media / social media platforms.
